Sealed quotations are invited from the interested reputed travel Agencies/Tour Operators or private individuals for providing 01(one ) Innova Crysta (white colour ) A.C. Diesel/Petrol driven vehicle, which shall conform to the terms & conditions (Annexure-II) for official use in the Odisha Real Estate Regulatory Authority located at Plot No.371, Vivekananda Marg, Bhubaneswar-751014 on monthly rent basis.

1. The vehicle must be in Road worthy condition, shall not more than 3 years old from the date of initial registration and must have valid registration Certificate, Insurance Certificate, fitness Certificate, valid **Contract Carriage Permit**, proof of up to date tax payment etc. which are mandatory for plying of vehicle.
2. The Driver of the vehicle must have a valid driving licence for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
3. The Driver should be well behaved, gentle and obedient in nature.
4. A sum of Rs.5000/- ( Rupees Five thousand ) only shall be deposited by the intending bidders in shape of Account Payee Bank Draft drawn in favour of ORERA, Bhubaneswar payable at Bhubaneswar and submitted along with the quotation paper as security deposit. After completion of tender process, the amount will be refunded to unsuccessful bidders.
5. The monthly rate of hire charge be quoted separately in the general bid information ( excluding fuel and lubricants).
6. The vehicle must achieve a fuel efficiency 09 Kms. Per litre.
7. The details of the make and year of manufacturer of the vehicle, registration no, mileage (Kms. covered per litre ) and name of the Driver with Driving Licence No. and period of validity should be

specifically provided in the general bid information to be furnished with quotation ( Annexure-III).

9. The application form of quotation containing general bid information & terms and conditions for Hiring of Vehicles etc. will be available with Accounts Branch of ORERA, Bhubaneswar on payment of Rs.100/- during working days from dated 12.03.2019 to 27.03.2019 up to 12.30 PM.

11.The selected vehicle owner shall have to execute an agreement with the office as per prescribed terms and conditions of the Government in Finance Department, Odisha and accordingly provide the vehicle.
