EXPRESSION OF INTEREST FOR SELECTION OF TRANSACTION ADVISOR FOR IMPLEMENTATION OF ENERGY EFFICIENT STREET LIGHTING PROJECT IN GREEN FIELD AREAS IN 112 ULBS IN ODISHA

The Government of Odisha (GoO), through Housing and Urban Development Department (HUDD) has set up Odisha Urban Infrastructure Development Fund (OUIDF) to develop and finance urban infrastructure projects in the state of Odisha.

With an aim to reduce energy consumption, it is proposed to implement Energy Efficient Street Lighting Project in green field areas in all 112 ULBs in Odisha with OUIDF assistance. It may be noted that Odisha Government's Housing and Urban Development Department inked a pact with Energy Efficiency Service Limited (EESL), for retrofitting of existing conventional street lights with Energy Efficient Street Lights.

In this regard, OUIDF invites Expression of Interest from reputed Consultancy Firms for providing Transaction Advisory Services for implementation of Energy Efficient Street Lighting Project in green field areas in 112 ULBs. The Transaction Advisor shall have experience in carrying out technical studies, providing transaction support for energy efficient street lighting projects. The broad scope would include -

- carrying out necessary surveys to ascertain the type of road, no. of lights and lux levels, poles and other support infrastructure,
- estimate project cost and viability analysis
- appropriate project structure for implementation
- transaction services for selection of implementing agency
- monitoring support during implementation

The Transaction Advisor shall possess adequate equipment for carrying out the necessary surveys.
